RE: ECONOMIC PROPERTY & CASUALTY INSURANCE COMPANY, LTD. (BAHAMAS)

We have been requested by the California Insurance Department, acting in accordance with and pursuant to Section 1765.1 of the Insurance Code, to advise all Surplus Line brokers and Special Lines Surplus Line brokers that effective March 17, 1993, unless and until notified by the Department to the contrary, the above insurer should not be employed for placements of California business. No further new or renewal business may be placed with the company.

This Order is based on a voluntary withdrawal by Economic Property & Casualty Insurance Company, Ltd because of its failure to respond to requests made by the Department of Insurance for "verification of assets, an audited financial statement, and an actuarial opinion." Also, though the Company agrees not to write any new or accept any renewal business, it will continue to honor and service claims.

Please issue a bulletin to your members notifying them that **Economic Property & Casualty Insurance Company, Ltd.** (Bahamas) is unacceptable pursuant to CIC S 1765.1 for placement of new or renewal business.

Please inform your members in the bulletin that this order is based on a voluntary withdrawal by the Company, following the Company's failure to respond to requests by the Department for verification of assets, an audited financial statement, and an actuarial opinion, among other things.

Economic Property & Casualty Insurance Company, Ltd. agrees not to write any new business or accept any renewal business. This company will continue to honor and service claims.

Attached hereto are copies of the Company's correspondence of February 8, 1993 to its "sponsoring Broker" Mercantile Insurance Brokers. Likewise attached is a copy of broker Mercantile's letter of February 8, 1993 to the Department of Insurance.
