The California Department of Insurance issued on July 7th its initial <u>List of Eligible Surplus Line Insurers (the "LESLI" list)</u>, effective June 30, 1995, or later, depending on the approval date on the attached list.

Attached is a copy of the Department's letter and the initial list, all of which should be self-explanatory.

Please note:

- as additional insurers are approved, we will issue addenda to the list;
- a Form A filing is not required for placements made with LESLI listed insurers;
- placements under Regulation 2174 filings may be continued until their expiration.

Dear Mr. Pugh:

Enclosed is the initial publication of the master List of Eligible Surplus Line Insurers ("LESLI list") established pursuant to California Insurance Code ¤ 1765. 1. The insurers on the LESLI list have been approved by the Insurance Commissioner as acceptable insurers for the placement of surplus line business in California. A Form A filing is required for placements made with insurers on the LESLI list.

One hundred and thirty-five (135) insurers have filed for approval and placement on the LESLI list. The

omission of an insurer from this initial master list should not be construed as a reflection of the Department's evaluation of that insurer's acceptability. The Department is processing the filings on a first-come first serve basis and some filings have yet to be reviewed. As additional insurers are approved, they will be added to the LESLI list by addendum. The addenda will be forwarded to your office for dissemination to your members.

Insurers and brokers that have a current filing under Regulation 2174 may continue to conduct a surplus line business in California until the expiration of their 2174 listing which, in most instances, is December 31, 1995.

Please distribute the LESLI list to your members. Thank you for your assistance.
