

STAMPING FEE DECREASE TO 0.35% - EFFECTIVE JANUARY 1, 1996

Following the recommendation of the Stamping Office and Contact Committee, the Executive Committee approved a decrease in the stamping fee from 0.50% to 0.35% effective January 1, 1996.

NEW AND RENEWAL BUSINESS

All new and renewal policies/certificates, and extension endorsements, with an effective date on or after January 1, 1996 will be at 0.35% stamping fee.

ADDITIONAL AND RETURN PREMIUMS

Policies/certificates effective prior to 01/01/96.

For any endorsements (excluding extension endorsements), audits, installments or cancellations applicable to **policies/certificates with an effective date prior to 01/01/96**, the stamping fee used at the inception date of the policy/certificate will be used for the entire policy term regardless of the effective date of the additional or return premium.

EXAMPLE: **Policy term 7/30/95 to 7/30/96**
 Stamping fee: 0.50%

Endorsement effective 08/01/95 - use 0.50% stamping fee
Endorsement effective 03/01/96 - use 0.50% stamping fee

It is not necessary to separate your batches by stamping fee; our computer will automatically do this for you.
