Current "In-Transition" Non-admitted Insurer Status

We have received numerous inquiries from the brokerage community regarding the current status of the remaining Regulation 2174 companies which have applied for "LESLI" (List of Eligible Surplus Line Insurers) status under SB 959, especially in the case of "program" business. While the financial reviews of those companies have been completed, there are still some final procedural and documentary matters pending with the California Department of Insurance.

Since the resolution of these matters is in the hands of the Department, we are not in a position to give the current status of the remaining companies. (As our members are undoubtedly aware, those companies not on the LESLI list as of January 1, 1996 would not be eligible for new or renewal business in California).

We urge brokers who need information about any of the remaining carriers to contact the company's submitting broker, the company itself and/or Dennis Ward (415 904 5866) or Carol Fistler (415 904 5674) at the California Department of Insurance.

For your convenience, those remaining insurers and their submitting brokers are shown on the list attached.
