The California Department of Insurance ("CDI") has requested the SLA advise its Members that St. Paul Reinsurance Company Limited ("St. Paul" or the "Company") has been reinstated to the LESLI without any lapse in its eligibility. St. Paul's previous withdrawal (SLA Bulletin #945) from the LESLI was premature. It is the Company's intent to remain in compliance with California surplus line eligibility requirements until all policies that are bound by its coverholders expire by their terms.
