RE: UPDATE TO THE LIST OF ELIGIBLE SURPLUS LINE INSURERS (“LESLI”)

The California Department of Insurance (“CDI”) has issued an update to the LESLI as per the attached Addendum #2003-01. Please update your LESLI binder accordingly. Also enclosed is the LESLI in its entirety as of January 16, 2003.

With regards to Lloyd’s Syndicates with limited status, these Lloyd’s Syndicates are listed for their respective (2001 and 2002) underwriting year of account only. According to Lloyd’s, these Syndicates may have issued binding authorities during their respective year of account that are still in effect or have been extended to 2003 at the end of the Syndicates’ year of account. Under the terms of such binding authorities, the Syndicates may continue to write U.S. business for the duration of the binding authorities, and that business will continue to be protected by the U.S. Situs Trust Deeds – Surplus Lines. As such, business placed by these Syndicates during 2003 will continue to be acceptable, as long as the business was placed under the binding authority issued by the Syndicates during their respective year of account.
